Holiday boat: A kind of boat used for recreational purposes serving as an accommodation as well, less than 15 metres long, with small water draught and a passenger capacity of 3-12 people. It is rentable as a houseboat or canal boat in Europe and its use does not require any licence in case the boat is operated as a part of a fleet on rivers, lakes and channels with little traffic.
